

Benefits of Having a Will

A valid Will ensures that your wishes are known and carried out after your passing. Without a valid Will, your estate will be settled according to the applicable laws of intestacy in the jurisdiction where your assets are located when you pass away.

How to Leave a Gift in your Will

There are three main types of gifts you can leave to ADRA.

Residuary Bequest:

After making provisions for your loved ones, you can leave all or a percentage of the remainder of your estate to ADRA Australia.

Percentage of Your Estate:

You can nominate a percentage from 1% to 100% of your estate to ADRA Australia.

Specific Bequest:

You can leave a specific sum of money or an item such as real estate, shares, artwork or valuable belongings.

Recommended Wording

After making provisions for your loved ones, if you decide to include ADRA Australia in your Will, here is some suggested wording:

"...to Adventist Development and Relief Agency Australia Limited of 146 Fox Valley Road, Wahroonga, New South Wales [ACN 109 435 618] to be applied under the direction of its Board of Directors for its charitable purposes (in the strict legal sense)."
